

## **“NCAA<sup>R</sup> Winning Combination” Sweepstakes Official Rules**

National Collegiate Athletic Association “NCAA” is a non-profit,  
501(c)(4) corporation

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. The “NCAA Winning Combination” Sweepstakes (**the "Sweepstakes"**) is sponsored by the: National Collegiate Athletic Association (“NCAA”), P.O. Box 6222, Indianapolis, IN 46202 (**the "Sponsor"**).

**I. ELIGIBILITY:** Sweepstakes begins at 12:01 a.m., Eastern Daylight Time (“EDT”), Friday, March 6, 2009 and ends at 11:59 p.m., Eastern Savings Time (“EST”), Monday, July 2, 2009 (the “Promotion Period”). Sweepstakes open to all legal residents of the 50 United States and District of Columbia (“DC”), who are 18 years of age or older at time of entry. Employees, officers, and directors of the NCAA, its affiliated organizations, companies, subsidiaries, franchisees, distributors, dealers, advertising and promotion agencies, any and all other entities directly associated with this Sweepstakes (“Sweepstakes Entities”), and the immediate family members and members of the same household of any of the above are **not eligible to participate**.

### **II. HOW TO PARTICIPATE:**

- 1.) To enter the Sweepstakes, visit the Sponsor's website, [www.ncaawinningcombination.com](http://www.ncaawinningcombination.com). Select "Click to Play" from the interface to begin the entry process. The site hosts a series of three trivia questions for participants to test their skill. You have two (2) chances during the game to answer each question correctly. Some questions include a research link to help you find the right answer. You are required to answer all three (3) questions correctly to successfully enter each week's Sweepstakes drawing. If your answers are incorrect, you have an unlimited opportunity to play the game again. Once you have answered the three questions correctly, you will be prompted to complete the on-line registration (Name, address, age, E-mail address, day-time and evening phone number). You may enter the drawing once per day, however in a random draw procedure, an entrant can only win one (1) prize per week. Any violation or attempt to violate this restriction may cause Sponsor to disqualify all of such person's eligible entries. All weekly entries must be submitted and received by 11:59 PM EST each Thursday during that week's Promotion Period, as stated in the “Prize Description, Drawing and Notification Schedule” in Section V.

**IV. PRIZES:** One Hundred Twenty Three (123) First Prizewinners will be selected weekly as listed in the "Prize Description, Drawing and Notification Schedule" located below.

**Three Event First Prizes:**

- NCAA 2010 Final Four Trip for two (2): The winner can choose between a trip for two to the 2010 NCAA Division I Men's Basketball Championship in Indianapolis, Indiana, or the 2010 NCAA Division I Women's Basketball Championship in San Antonio, Texas. The trip includes: Round-trip coach airfare for the winner and a guest (ticket capped at \$600 each); a 3 day / 4 night stay in an Indianapolis or San Antonio hotel; transportation vouchers for airport and city transportation during the event; \$400 spending money (in the form of a gift debit card or similar); and two tickets to the semi-final and championship games "ARV" \$500. Total Approximate Retail Value of prize ("ARV") \$2,700.
- NCAA 2009/10 Championship for two (2): The winner is awarded a trip for two to a 2009-2010 academic year NCAA Championship of the winner's choice. Trip includes: Round-trip coach airfare for the winner and a guest (each ticket capped at \$600); a 3 day / 4 night stay in a hotel in the city of the NCAA championship; transportation vouchers for airport and city transportation during the event or up to a 5-day rental of a mid-size car depending on the championship selected (transportation option to be selected at the NCAA's sole discretion), \$100 spending money per hotel night (in the form of a gift debit card or similar), and tickets to the championship (value dependent upon the championship selected). Total "ARV" Prize \$3,100.
- Driving Experience for two (2): The winner is to receive a trip for two to participate in the two-day Driving Experience at Bondurant Driving School in Phoenix, Arizona.
